





## Residents' Parking

Moves are afoot to make our estate part of a 'parking zone'. This would mean time restrictions, resident permits, possibly pay-by-the-hour bays, all designed to dissuade commuters from using residential streets for free parking during the working day.

A joint committee of City and County cllrs has proposed 26 Parking Zones (to add to the City's existing 14 parking schemes). Details can be found here: <https://tinyurl.com/h295qsw>

Our estate would be in **Zone 10**, along with Gurney and Courtney Ways, Ascham, Gilbert & Metcalfe Roads, Atherton Close, east side of Carlton Way, north side of Milton Road and west side of Arbury Road.



If this proposal is approved by the County Council, then residents will be asked if they want a scheme for their zone. If 50% or more of respondents are in favour, the scheme will go ahead.

Residents who opt for a permit must pay a single start-up fee. For De Freville Ave this is currently £52. There is also an annual fee of the same amount. As an incentive this time round, City Deal will pay the initial fee. De Freville scheme details can be found here: <http://tinyurl.com/j895xzs>

There is some other negotiation going on in the background. Zones 5 & 6 would be the first to be balloted. Zone 10 could possibly combine with Zone 5 to achieve an early decision. Zone 5 includes Hawthorn Way, Chesterton Hall Cres., George St and Herbert St. But capacity in Herbert St. would be halved because properly marked-out parking bays would be allowed only on one side. So, **displacement** will be an issue to consider but only if the residents in Zone 5 vote to go ahead. If Zone 10 decides to go ahead separately, then displaced cars from Herbert St will not be able to park here. If Zones 5 & 10 do combine then permits will be valid across both areas.

The Milton Road Local Liaison Forum (LLF) was set up by City Deal to enable local feedback on the details of their proposed 'Do-Something' design. HPERA was allocated one seat on the LLF committee and our members contributed to a series of six workshops held last autumn.

To get a more co-ordinated effort to represent the wishes of local people, HPERA became a founder member of **The Milton Road Alliance** along with Milton Rd Residents' Association and CamCycle.

### The 'Do-Optimum' plan

This collaboration has resulted in an alternative vision and design layout that we have termed the 'Do-Optimum' plan – see full details at the HPERA website and at [www.miltonroadalliance.org](http://www.miltonroadalliance.org).

Centred around the idea of Milton Rd being a community space rather than just a 'bus-corridor' the Do-Optimum alternative has now been formally voted on and adopted by the LLF as a series of resolutions that will be presented to the City Deal Executive Board in March 2017.

The team has also published a more wide-ranging paper asking the question:

### Yellow Lines

Double yellow lines at the junction of Hurst Park Ave with Milton Rd were finally approved by a Joint City/County Committee on 24<sup>th</sup> January (2½ years after funding was granted). They will stretch 21m up Hurst Park Ave on the north side and 63m on the south side.

### Arbury Pop-Up Kitchen

The second pop-up kitchen event of 2017 will take place at Arbury Road Baptist Church on 23rd February. These are being held on **the last Thursday of each month at 18.15 – 20.30**.
